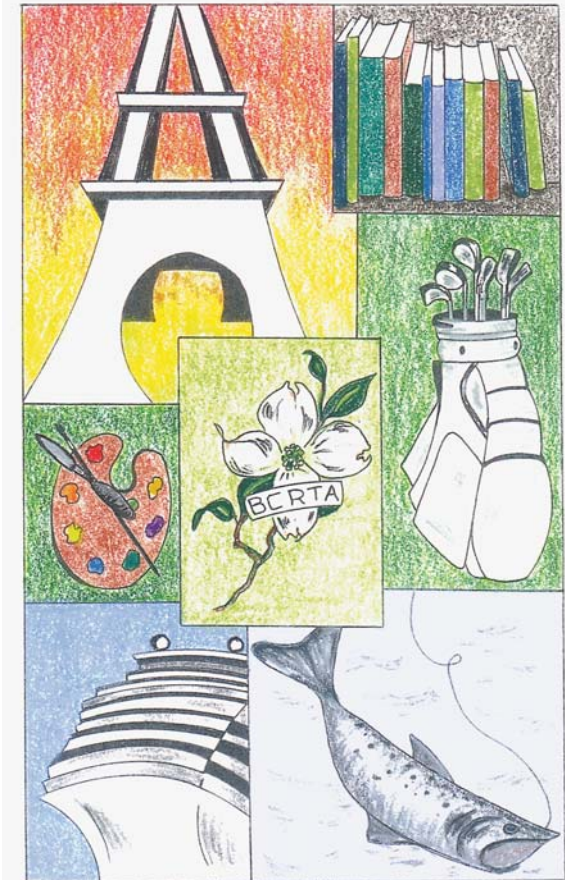

BRANCHES

You are encouraged to join one or more of the branches throughout the province. BCRTA branches organize programs that keep members informed and connected through newsletters, websites, and events. They organize activities that may include the preservation of district education heritage, speakers and entertainment at lunch meetings, and involvement in community services. They may hold garden parties and barbeques, or sponsor bridge clubs, walking clubs, coffee klatches, and discussion groups. Branch membership is open only to members of the BCRTA. FEES

The annual BCRTA fee, currently \$35, is determined at the Annual General Meeting. Branch fees are determined at the Branch AGM and are listed below. The membership year is from July 1 to June 30.

If you are receiving a pension from the BC Teachers' Pension Plan or College Pension Plan, your fees will be deducted from your September pension.

If you are not receiving a pension from one of these plans, please send a cheque or money order for your provincial and branch fees by June 30 of each year to the BCRTA provincial office.

History

The B.C. Retired Teachers' Association was incorporated as a Society in 1955 with its main objective "to guard the interests and to promote the welfare of its members." Through the efforts of many dedicated people, the Association has grown to a large influential organization with Branches throughout the Province.

Provincial Organization

The Directors of the BCRTA are elected at the Annual General Meeting. Their role is to carry out the directions of the AGM and take initiative in serving the aims of the Association.

Membership in the BCRTA provides a means of protecting the economic interests of its members, as well as keeping in touch with former colleagues and friends through the Branches of the Association.

The BCRTA is an affiliate member of the Canadian Association of Retired Teachers and of the Council of Senior Citizens' Organizations. These groups, strong in number, lobby federal, provincial, and local governments regarding issues affecting members. Your membership in the BCRTA enhances the strength of the collective voice of these organizations.

Services

The BCRTA is the voice of retired educators. As membership grows so does our ability to serve our members.

Provincial Office

Our provincial office is the service centre of the Association. The office administrator and staff give assistance to members on the many issues related to their welfare. Toll-free lines provide members throughout the province with office access.

Services

Pensions

The BCRTA assists in retirement planning seminars and holds support seminars for retired educators.

BCRTA members represent the Association on the BCTF Pension Committee and on the Teachers' Pension Plan Advisory Committee. These committees represent the interests of all active and retired BC educators. One BCRTA representative is always appointed to the Teachers' Pension Board of Trustees.

Medical/Dental

The BCRTA provides information and assistance regarding the Medical Services Plan of BC (MSP), EHB, and dental plans with Pacific Blue Cross.

Travel Insurance

MEDOC travel insurance, through Johnson Inc., provides comprehensive coverage for medical emergencies, travel cancellation, or delay while traveling outside of BC. Preexisting medical conditions do not exclude members from coverage. Insurance is available only to BCRTA members.

Other Insurance Plans

Offering members affordable, comprehensive benefits at group rates are other BCRTA plans administered through Johnson Inc.: Home Insurance, Long Term Care Insurance, and Life Insurance & Legacy Planning.

PRIVACY AND CONSENT
